The Town of West Rutland is accepting sealed bids for the sale of a 2006 Ford F550 KME Mini-Pumper as described below.

A minimum bid amount of \$100,000.00 is requested. The sale of the truck will be awarded to the highest bidder in accordance with the terms outlined below. The Town of West Rutland reserves the right to reject any or all bids and to accept bids below the minimum requested bid.

All bids shall be plainly marked: "SEALED BID – 2006 FIRE TRUCK". No faxed or emailed bids will be accepted. Bids must be received by 11:00 a.m. on October 15th, 2024, and any bid received after that time will not be considered. Bids will not be opened at this time.

The final selection shall be made at the Selectboard meeting on October 15th, 2024. All bidders may request a list of bid results following the Selectboard meeting. Full cash payment, or verified check, is required prior to transfer. The vehicle is expected to be available in October 2024, but is contingent upon the delivery of a replacement vehicle to the seller.
